(FS) against 20% DR Quota in the NE-4 grade in the pay scale of Rs. 31000-92000/-subject to meeting the following required qualifications/eligibility criteria: -

			<u>Disqualification: -</u> Physical deformity, chronic diseases, color blindness night blindness, squint eye, flat foot, bow legs, knocking knee and refractive error will be considered as disqualification.

The eligibility of applicants with respect to Age (should be below 50 years), Educational qualification, experience etc. shall be determined as on 30.11.2019. Moreover, the reservation criteria shall be in accordance with the AAI rules.

Selection Process: -

Recruitment under DR Quota will be done through verification of physical standards, written test, driving test, and physical endurance test.

Training: -

The selected candidates should undergo training. During the training period, candidates will be given training of CFTs. The candidates who do not qualify the CFT test will not be appointed.

The interested eligible departmental employees working in Group 'D' who are willing to serve at various airports under the Eastern Region may submit their applications in the enclosed prescribed format "Through Proper Channel". The above information, as such, may be widely circulated among all Group "D" at your station/under your control and applications of all such eligible candidates may be obtained in the enclosed format duly verified from the official records of the incumbents by the HR Deptt. of the respective station and forward the same to RHQ, ER, Kolkata on or before 30.11.2019 positively. Applications received beyond the stipulated date will not be entertained.
