TERMS AND CONDITIONS:

1. Rules of Reservation will be implemented as per Govt. of India instructions.
2. The appointment shall not confer any right or preference for regular appointment.
3. No claim for any service benefit like, PF, Pension, Gratuity, Medical Allowance, Seniority, Promotion and Leave will be admissible.
4. Selected candidates are eligible for 1 day leave per month.
5. Candidates must be registered with Karnataka Medical Council or MCI before joining the post.
6. Candidates in the Government Service should submit "No Objection Certificate" from the employer at the time of interview.
7. No TA/DA will be admissible for interview or joining.
8. ESI Corporation may increase or decrease or cancel filling up of any post without assigning any reasons at the discretion of the Appointing Authority.
9. The application should be submitted in the prescribed format only. If the applications found incomplete will be summarily rejected.
10. The candidates claiming reservation/age relaxation on grounds of belonging to OBC should submit the Community Certificate in **Annexure "A"** prescribed Govt. of India, Department of Personnel and Training O.M No. 36036/2/2013-Estt.(Res.), dated 30.05.2014 failing which the benefit of reservation/relaxation will not be given and their application shall be rejected and no request / correspondence will be entertained. Certificates issued in other formats not be accepted and the candidate will be treated as "General category" for all purposes. The format in Annexure "A" is uploaded along with the advertisement.
11. The candidates appointed under PWD Quota will be adjusted against the vacancy of respective category of UR.
12. The Dean has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of appointment.
13. The candidates are advised to bring their application (prescribed format attached) along with 2 photographs and 1 set of self attested copies of the following documents:

 - c) MCI/ KMC Registration

15. Candidates are requested get themselves registered within the time mentioned above, failing which they will not be allowed to appear for interview.

16. Selected candidates have to deposit an amount of Rs. 85,000/- as refundable Security deposit (non interest bearing) (Drawn in favour of ESIC A/C No.1). However, this amount will be appropriated towards administrative cost in case, the candidate resigns/terminates his/her contract ESIC terminates the contract on account of any misconduct **within Six months** of the commencement of the contract with or without prior notice.
