Sub : Re-engagement of Retired Gazetted Officers as **Consultant (Electrical)**
in exigency of service.

dated 25.10.2018 and 20.12.2018.

1. In terms of Railway Board's letters under reference and with the approval of the Competent Authority, applications are invited from interested and willing retired gazette Electrical officers from all over Indian Railways (Junior Scale/Senior Scale only) for re-engagement in Junior Scale only as **Consultant (Electrical)** in view of exigencies of services. The vacancies for re-engagement in Junior Scale as Consultant (Electrical) are as under.


2. Interested and willing retired Gazetted Electrical officers from all over Indian Railways (Junior Scale/Senior Scale only) may apply for re-engagement against Junior Scale/Asst scale post only as Consultant accepting the following terms and conditions.

- The engagement of Consultant shall not be considered as a case of re-employment.
- Maximum age limit of the re-engagement shall be 65 years.
- The period of engagement shall be initially for one year and further extendable as per requirement of the administration.

- (d) While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices (as done in selection from Group 'C' to Group 'B').
- (e) Re-engaged officer shall not be entitled for requisites such as HRA, CCA, Transport Allowance, Residential Accommodation etc. However, when required to travel in connection with official work, TA/DA admissible to regular employees working in the same grade will be admissible.
- (f) 12 days leave in a calendar year on pro-rata basis is admissible.
- (g) The designation shall be **Consultant (Electrical)** as indicated above.
- (h) Re-engaged officers shall be discharged immediately on joining of selected candidate(s) from UPSC or departmental selection or as per the recommendation of PHOD/CHOD concerned.
- (i) Re-engaged officers shall be given responsibilities as defined in the Terms of reference (TOR) listed in this link.
- (j) The consultant shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know/have the same.
- (k) They will not be made incharge of the unit like Branch officer in the Division or independent incharge in the Construction Unit.
- (l) Re-engaged officers shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate.
- (m) If selected, the reengaged officer should work anywhere in the zone.
- (n) Other terms and conditions including the monthly remuneration of a retired officer being re-engaged will be governed by instructions contained in Railway Board's letters dated 25.10.2018 and 20.12.2018 under reference and further instructions issued from time to time.

3. How to apply :-

The retired Railway gazette Electrical Officers (**Junior Scale/ Senior Scale only**) intending to join as Consultant through re-engagement should apply on prescribed format (enclosed as Annexure 'A') and submit the same along with required documents viz self attested photo copy of P.P.O, Service Certificate and 04 copies of recent passport size photograph so as to reach to Dy.Chief Personnel Officer/Gaz, Personnel Branch, Office of the General Manager, Southern Railway, Chennai-600 003 latest by 23.03.2020.
