In view of Public Health Emergency services due to COVID-19 pandemic and in terms of Railway Board's instruction issued vide letter No.2020/E(GR)II/COVID-19/WFH/1 dt.28.03.2020, 31.03.2020& 01.04.2020 , Moradabad Division of Northern Railway invites applications for working at the following stations from the retired Government Medical Officer of Central/State Government and also from "Open Market" as well as CMPs' whose tenure has expired or is going to be expired for engaging full time 26 Contract Medical Practitioners (UR – 13, OBC -07, SC – 04, ST- 02)as per details given below:

1. Experience:

The candidate with prior experience will be given preference. Previous service rendered on Indian Railways (including on contract)/any other hospital/organization may be indicated. However, candidate without experience can also apply.

2. Remuneration for Retired Government Medical Officer of Central/State Government:

Monthly remuneration will be paid by reducing his/her pension from Last Pay Drawn (i.e. Basic pay + DA) (Pay plus pension should not be more than the last pay drawn).

3. Place of working: As indicated in the posting station column.

4. Qualifications:

MBBS from a recognized University and must have completed internship for one year and should be in possession of a valid Registration Certificate of any of the State Council of India. In case of specialists they should have PG Qualification/Diploma Degree in the specialty recognized by Medical Council of India. In the case of Super Specialist, they should have qualification in super specialty.

Candidate who fulfills above terms and conditions and having requisite qualification should be present himself/herself on the scheduled date, time and venue with their original certificate of date of birth, educational qualification, experience, caste (in case of candidates belonging to reserved community) registration with medical council along with self attested two sets of photocopy of each documents and six photographs along with ID Proof.

In case the speciality candidates are not available, then the vacant seats shall be filled from GDMO.

5. Age Limit:

- a) Not exceeding 50 years as on 01-04-2020 (05 years age relaxation for SC/ST and 03 year for OBC)
- b) Not exceeding 65 years for retired IRHS officers/retired Government Medical officers of State Government /Central Government.
- c) Reservation policy will be as per extant rules.

6. How to apply:

8. Joining of the selected candidates: -


The selected candidates have to join immediately in the event of selection.

9. Terms & Conditions:

1. Depending upon administrative exigencies, Railway administration reserve the right to modify number of vacancies and station of posting.
2. The CMP will not be allowed to do private practice
3. No TA/DA/Taxi/Conveyance charge shall be paid for appearing for Walk-In-Interview
4. Engagement of doctors would be on contract basis initially for a period of three month subject to further extension notification by Railway board for extension, if any, as per administrative requirement on the basis of assessment of performance of CMPs or up-to attaining the 65 years of age (in case of retired Govt. Medical Officers) whichever is earlier.
5. During the period of contract either party (the medical practitioner or Railway Administration) is free to terminate the contract on 15 days prior notice.
6. In case the medical Practitioner is found physically or mentally invalid or incapacitated the contract can be terminated forthwith.
7. Doctors engaged as CMPs shall not have any claim or right for his/her continuity in services or automatic extension of the terms of contract and shall not confer any right upon the selected candidate for filing any suit before any tribunal/court for extension and/or absorption in Railways.
8. After approval of panel by competent authority the panel will be uploaded at WWW.nr.indianrailways.gov.in and intimated through speed post/whatsapp/text message/e-mail/whatsapp. Candidates who do not report at the assigned date and time will forfeit their chance of contract engagement and such opportunity will be offered to the next empanelled candidates

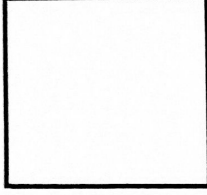
