- **2.4** The candidate must be a citizen of India and should be a Bonafide Himachali **or** candidates shall be eligible for appointment to Class-IV posts(s), if he/she has passed Middle or Matriculation examination from any School/Institution situated within Himachal Pradesh.
- **3. Age:** The applicant should be between 18 to 30 years as on **Q1-04-2020**.
