Sub:- Selection Board for the post of App. J.E. (C&W) in scale Rs. 9300 – 34800 + GP 4200 (Level 6 in 7th CPC)- Against 25% LDCE Quota- Intermediate Apprentice among serving Employees– C&W wing- Mech Deptt.- BCT Division.

It is proposed to conduct a selection to fill up 08 vacancies (GL=05, SC=03, ST=0) for the post of App. J.E. (C&W), Scale Rs. 9300 - 34800 + GP 4200 (Level 6 in 7th CPC) against the 25% LDCE quota from intermediate serving employees under C&W wing of Mumbai Division from the eligible candidates who have completed 3 years regular service in skilled grade and below 47 years of age on the date of this notification with the following educational qualification.

- 1) The employee must have passed 10+2 Science Stream.
- 2) The employee passed ITI/Act Apprentice Course/Diploma/Degree in the relevant trade is also eligible.

The employees selected as App. J.E. (C&W) Scale Rs. 9300 - 34800 + GP 4200 (Level 6 in 7th CPC) will have to complete the prescribed training of Apprentice for a period of 52 weeks as per training program & on successfully completion of training they will made eligible for posting of J.E. (C&W) scale Rs. 9300 - 34800 + GP 4200 (Level 6 in 7th CPC).

In view of the contempt petition No. 314/2016 in SLP(C) No. 4831/2012-Samta Andolan Samiti through President V/s Sanjay Kothari & others, Railway Board vide RBE No. 117/2016 has advised that RBE No. 126/2010 dt. 01.09.2010 is held in abeyance with immediate effect till further advice, and all further promotions of reserved category persons to unreserved posts will now be made by ignoring RBE No. 126/10 dt. 01.09.2010. It was further advised that, henceforth all promotions shall be subject to outcome of the main SLPs and the above mentioned contempt petition which are still pending. RBE No. 117/16 has further been clarified by HQ office vide letter dt. 15.12.16 cited under reference No. 3 that, the instructions of RBE No. 117/16 are applicable to all (Selection/Non selection) promotions of reserved category persons against unreserved post. If any reserved category employees come as per his merit/seniority/suitability against unreserved post in zone of consideration, the same should be adjusted against reserved post.

The above selection/promotion has been initiated/ordered only after ascertaining quantifiable data of representation of SC/ST employees in the grade, as per the post based rosters against roster point No. SC= ST= as per the orders of Supreme Court in M. Nagraj Case (P.S. No. 73/2016).

In view of the above the eligibility will be prepared by ignoring RBE No. 126/10 dt. 01.09.10 on the basis of RBE No. 117/16 and clarification by HQ Office vide letter Dt. 15.12.16.

In terms of RBE No. 117/16, the promotions for the above Selection/suitability are provisional and subject to the outcome of the pending Contempt Petition Civil No. 314/2016 and SLP Civil No. 4831/2012.

The last date of application is 20.07.2020.
