- (iv) Customize and integrate image relate applications through ANN and Fuzzy logics, image classification techniques, including unsupervised classification, supervised classification etc.
- (v) Efficient in using COTS and open source remote sensing software such as ERDAS Imagine, ENVI, QGIS, etc.

- (v) Perform complex data analysis using GIS and related extensions/add-ons, relational databases, and other computer software.
