POSTAL ASSISTANTS / SORTING ASSISTANTS / POSTMAN / MULTI TASKING STAFF (MTS)  
IN TELANGANA POSTAL CIRCLE**

Applications are invited online through URL <https://tsposts.in/sportsrecruitment> for the Direct Recruitment of meritorious sports persons from open market under **SPORTS QUOTA** for filling the vacancies of the following posts in Telangana Postal Circle.

1. Postal Assistant (PA) in Post Offices
2. Sorting Assistant (SA) in Railway Mail Service (RMS) Offices
3. Postman in Post Offices
4. Mail Guard (MG) in Railway Mail Service (RMS) Offices
5. MTS in Post Offices / RMS Offices / Postal Accounts Office

The recruitment process will be based on the guidelines issued by the Department of Personnel & Training, Government of India OM No.14034/01/2013-Est. (D) dated 03.10.2013; 01.09.2020 and 29.01.2021.

**2. Scale of Pay:**

**3. Probation and Training :**

- i) **Probation** : Candidates selected will be appointed and will be on probation for a period of two years.
- ii) **Training** : Training will be imparted to the candidates selected as prescribed by the Department of Posts.

**Note :** (i) The Chief Postmaster General, Telangana Circle reserves the right to revise / cancel the vacancies /to post the selected candidates to any of the Division / unit /office mentioned above or to any other place in Telangana Circle depending upon the category of post.

(ii) Options will be obtained from the selected candidates only. Allocation of unit will be decided as per merit and preference of the candidate subject to availability of vacancies etc.

## 5. Age Limit :

Sl. No.	Post	Maximum Age
01	Postal Assistant / Sorting Assistant	Between 18-27 years (Relaxable by 3 years for OBC and 5 years for SC/ST)
02	Postman / Mail Guard	Between 18-27 years (Relaxable by 3 years for OBC and 5 years for SC/ST)
03	MTS	Between 18-25 years (Relaxable by 3 years for OBC and 5 years for SC/ST)

The crucial date for determining the age limit shall be the last date for receipt of application i.e **24.09.2021**.

### **Note :**

- i) A special relaxation in age limit is allowed in accordance with DoP&T OM no.15012/3/84-Estt.(D) dated 12.11.1987 to a maximum of 5 years for all the applicants. Additional age relaxation for 5 years for SC/ST candidates and 3 years for OBC candidates is allowed.
- ii) Reservation Rule is only for claiming the exemption in fee and age relaxation. Such candidates should necessarily submit proof of age i.e., SSC Certificate and Caste Certificate for claiming exemption in fee and age relaxation.
- iii) The concession will be available only to those sportspersons who satisfy all other eligibility conditions relating to educational qualifications etc. and furnish a certificate in the form from an authority prescribed in these instructions.
- iv) No appointment can be made unless the candidate is, in all respects, eligible for appointment to the post applied for, and in particular, with regard to age, educational qualifications prescribed under the Recruitment Rules applicable to the post, except to the extent to which relaxations thereof have been permitted in respect of category of persons to which the applicant belongs.

## 6. Educational and other Qualifications:

- i) **POSTAL ASSISTANT AND SORTING ASSISTANT :**
  - a) The candidate must have passed 12<sup>th</sup> standard or equivalent examination from a recognised university or Board of School Education or Board of Secondary Education.
  - b) The candidates of higher qualifications will also be considered but they have to fulfil the above conditions. There will be no preference for higher educational qualifications.
  - c) The candidate will be required to furnish certificate of Basic Computer Training from a recognized Computer Training Institute

before issuance of appointment letter. Computer Training Certificates from Central Government / State Government / University / Board etc. will also be acceptable for the purpose. This requirement of Basic Computer Knowledge Certificate is relaxable in cases where a candidate has studied computer as a subject in Matriculation or Class XII or Higher educational qualification and in such cases a separate certificate will not be insisted upon.

**ii) POSTMAN :**

- a) The candidate must have passed 12<sup>th</sup> standard or equivalent examination from a recognised university or Board of School Education or Board of Secondary Education.
- b) Knowledge of LOCAL LANGUAGE i.e. TELUGU. The candidate should have studied local language as a subject i.e. Telugu at least up to 10<sup>th</sup> standard.
- c) The person appointed to the post of Postman shall acquire a driving licence to drive two wheeler or three wheeler or Light Motor Vehicle within a period of two years from the date of his appointment. However, the person with disability shall be exempted from the requirement of driving licence.
- d) The candidate not having valid driving licence at the time of appointment shall not earn periodical increment in pay till production of such licence or for a period of five years from the date of appointment whichever is earlier and after production of such licence or expiry of such five years period, pay shall be restored prospectively to the level pay would have reached as if periodical increment in pay was not withheld and no arrears shall be paid for the intervening period.
- e) The candidates of higher qualifications will also be considered but they have to fulfil the above conditions. There will be no preference for higher educational qualifications.
- f) The candidate will be required to furnish certificate of Basic Computer Training from a recognized Computer Training Institute before issuance of appointment letter. Computer Training Certificates from Central Government / State Government / University / Board etc. will also be acceptable for the purpose. This requirement of Basic Computer Knowledge Certificate is relaxable in cases where a candidate has studied computer as a subject in Matriculation or Class XII or Higher educational qualification and in such cases a separate certificate will not be insisted upon.

**iii) MULTITASKING STAFF (MTS)**

- a) 10<sup>th</sup> standard pass from a recognized Board.
- b) Knowledge of LOCAL LANGUAGE i.e. TELUGU. The candidate should have studied local language i.e. Telugu as a subject at least up to 10<sup>th</sup> standard.
- c) The candidates of higher qualifications will also be considered but they have to fulfil the above conditions. There will be no preference for higher educational qualifications.

Note in respect of educational Qualifications:

- (i) As per Ministry of Human Resource Development Notification dated 10.06.2015 published in Gazette of India, all the degrees / diplomas / certificates awarded through Open and Distance Learning mode of education by the Universities established by an Act of Parliament or State Legislature, Institutions Deemed to be Universities under Section-3 of the University Grant Commission Act, 1956 and Institutions of National Importance declared under an Act of Parliament stand automatically recognized for the purpose of employment to posts and services under the Central Government provided they have been approved by the University Grants Commission.
- (ii) Candidates must possess essential educational qualification from recognized Board/University before applying for the posts.
- (iii) Candidates have to scan and upload the images of original certificates.

7. **Sports Qualifications - Eligibility** (as on the last date of receipt of application) for consideration.

Sports eligibility for the Post of Postal Assistant / Sorting Assistant/ Postman / MTS.

i)	Sportsmen who have represented a State or the country in the National or International competition in any of the games / sports listed at para no. 8
ii)	Sportsmen who have represented their University in the Inter-University tournaments conducted by the Inter-University Sports Board in any of the games /sports listed at para no.8
iii)	Sportsmen who have represented the State Schools Teams in the National Sports / Games for Schools conducted by the All India School Games Federations in any of the games / sports listed at para no.8
iv)	Sportsmen who have been awarded National Awards in Physical Efficiency under the National Physical Efficiency Drive.

## 9. **List of authorities competent to award certificates on eligibility for recruitment of Sports persons :**

NOTE : (i) There is no time limit for validity of the certificate of sports. However, the candidate should be within the age limit prescribed.

#### 10. **METHOD OF SELECTION :**

Selection of the candidates will be made on educational and Sports qualification subject to fulfilment of prescribed conditions.

Meritorious Sports Candidates will be selected for appointment based on the instructions contained in the Department of Personnel & Training OM No. 14015/1/76-Estt.(D) dated 04.08.1980 as amended from time to time and consolidated instructions issued by DOPT OM No. 14034/01/2013-Estt.(D) dated 03.10.2013 and Postal Directorate, Department of Posts, New Delhi letter No. 17-07/2017-SPN-I (Pt.) dated 06.01.2021. The order of preference is as under :

- (i) **First Preference** : Candidates who have represented the country in an INTERNATIONAL competition with the clearance of the Department of Youth Affairs and Sports.
- (ii) **Second Preference** : Candidates who have represented a State / Union Territory in the Senior or Junior Level National Championship Organized by the National Sports Federations recognized by the Department of Youth Affairs and Sports or National Games organized by the Indian Olympic Association and have won medals or position up to third place. Between the candidates participating in Senior and Junior National Championships

/ Games, the candidates having participated and won the medal in Senior National championship gets preference.

- (iii) **Third Preference** : Candidates who have represented a University in an Inter-University competition conducted by Association of Indian Universities / Inter-University Sports Board and have won medals or positions up to third place in finals.
- (iv) **Fourth Preference** : Candidates who have represented the State Schools in the National Sports / Games for Schools conducted by the All India School Games Federation and have won medals or positions up to third place.
- (v) **Fifth Preference** : Candidates who have been awarded National Award in physical efficiency under National Physical Efficiency Drive.
- (vi) **Sixth Preference** : Candidates who have represented a State / Union Territory / University / State School Teams at the Levels (ii) to (iv) above but could not win a medal or position in the same order of preference.

**NOTE :**

- i) Participation in individual and team event / item will be given the same preference.
- ii) In case there are candidates with same level of achievement i.e. International level, National level, University level etc. the following criteria will be followed.
  - a) Candidate who has secured a higher position or was more than one medal will be given preference.
  - b) In case of tie after applying conditions (a) above, date of birth of the applicant.
  - c) In case of tie in the date of birth, first name of the applicant in alphabetical order.
- iii) Decision of the competent authority i.e. Chief Postmaster General, Telangana Postal Circle, Hyderabad will be binding.

11. **DISQUALIFICATION:**

- a) No person who has entered into or contracted a marriage with a person having spouse living or
- b) No person who has a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to service. Provided that Central Government may if satisfied that marriage is permissible under the personal law applicable to such person and to other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

12. **DISCLAIMER :**

- (i) Vacancies notified are subject to change without assigning any reason.



- (ii) The Department reserves the right to cancel the recruitment without assigning any reason.

**13. INSTRUCTIONS TO THE APPLICANTS :**

- i) Original documents viz, (i) Date of birth as entered in the Matriculation or Secondary School Leaving Certificate or in a certificate recognized by an Indian University as equivalent to Matriculation or in an extract from a Registrar of Matriculates maintained by a University (ii) educational qualification (iii) Form1/ Form2/ Form3/ Form4/ Form5 required for submission as per the level of participation mentioned (iv) Caste certificate (SC/ST/OBC) in prescribed proforma (Annexure II to III) issued by competent authority, if any, etc. should invariably be uploaded along with the application form. Further self-attested latest coloured passport size photograph, shall also be uploaded.
- ii) If the prescribed documents are not uploaded along with the application, the application will not be considered.
- iii) Selected candidates shall be required to give an undertaking to the effect that they shall not apply for inter-change transfer before rendering regular service for a minimum period of 2 (two) years.
- iv) All relevant documents and certificates will be required to be produced in original at the time of appointment.
- v) The Department reserves the right either to revise the number of vacancies or to cancel the recruitment, if so warranted and the Department will not be liable to return the fee or pay any compensation on the applicant's application.
- vi) In case of failure to comply with the instructions / conditions prescribed in the notification, application will be rejected. No communication in this regard will be entertained.
- vii) First name of the candidate should be as noted in SSC certificate.
- viii) Candidate should be citizen of India.
- ix) Candidate can apply for any category of the posts mentioned in the Notification. If selection is considered for higher grade post, subsequent posts will be automatically forfeited for the said candidate.
- x) Candidates having participated in more than one sport/game, are also eligible to apply duly uploading the certificates in proof thereof of such participations.
- xi) Candidates who are already in service have to produce NOC before appointment. An undertaking should be given by the candidate in the application itself.
- xii) In case the selected candidate did not turn up when offered appointment, next meritorious candidate will be considered for selection / appointment.
- xiii) Candidate can apply for any category of the posts mentioned in the Notification.

- xiv) Ex. Servicemen can also apply. However, they will not be given any special preference.
- xv) Selected candidates must produce one of the Identification documents like Aadhaar card, PAN card, Driving licence, Voter ID or Passport at the time of verification of original documents.
