1. Answer *all* of the following (in not more than 200 words each) :

- (a) Discuss the reasons for the phenomenal growth of Buddhism in Ancient Period.
- (b) Analyze the socio-economic conditions during the Gupta Age.
- (c) Assess the administrative and the cultural achievements of the Chola Empire.
- (d) Review how far Aurangzeb was responsible for the disintegration of the Mughal Empire. Give reasons for your answer.
- (e) What were the differences between moderates and extremists in the Indian National Movement?

2. Answer *all* of the following (in not more than 200 words each) :

- (a) Enumerate the different stages of highway construction in India during the neo-liberal era.
- (b) "Earthquakes are by far the most unpredictable and highly destructive of all the natural disasters." Examine the statement with reference to seismological zones of India.
- (c) "Astronomical causes seem to be primarily responsible for climate change." Comment.
- (d) "Digital Agriculture Mission is an alternative for transformation in agriculture sector." Discuss.
- (e) Why are frequent fires in semiarid forests beneficial for maintaining community habitats? Explain it in the context of recent fires in California State of the United States.

3. Answer *all* of the following (in not more than 200 words each) :

- (a) Explain the benefits of Pradhan Mantri Ujjwala Yojana (PMUY) undertaken by the Government of India.
- (b) Examine the impacts of USA's decision to enhance tariff on several Indian goods on the Indian economy.
- (c) Does non-conventional energy have the prospect for sustainable development in India? Explain your answer.
- (d) "MGNREGA is a successful welfare-oriented Act for the upliftment of rural people in India." Elucidate.
- (e) Why is concentration of industries very poor in North-Eastern part of India? What steps have been taken by the Government of India to address the issue?

4. Answer *all* of the following (in not more than 200 words each) :

- (a) "The Directive Principles of State Policy have primacy over the Fundamental Rights in the Constitution of India." Comment.
- (b) "Federalism in India is the key to efficient administration and autonomy to the States." Critically examine the statement.
- (c) "Financial committees of the Parliament of India ensure financial propriety of the government." Discuss.
- (d) Examine the success and failures in the implementation of the 73rd Constitutional Amendment Act.
- (e) Assess the role of BRICS to build an alternative credible financial institution to serve the present world economic order.
